Fire Guts Ravens Bluff Hall of Records

City Government is shambles without records, Knight's Council orders roll-call

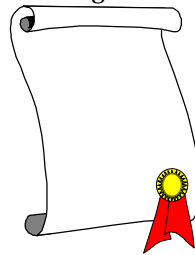

Late last night a huge fire erupted in the Ravens Bluff Hall of Records. The Hall was completely destroyed before the gallant efforts of the Ravens Bluff Red Ravens could bring it back under control. The city government awoke to a government without many of its documents. Not all the city's plans were in the Hall of Records but many were, many one of kind original documents. One example would be the treaty and trade agreement with The Murkos, which was destroyed in the fire. The largest portion of documents and the ones, which have fueled an additional debate since the fire, were the many documents created during the rule of Mayor Belanor Fenmarel. The Trumpeter has found out that there are still those in the City Government and it's organizations that support Belanor and it is rumored that one of these "loyal" officials might have been the one who set the blaze.

The Government's reaction was depressed with no clear indication of any action. The Clerical Circle and Knight's Council however, acted immediately. The Clerical Circle appointed a representative to look into the fire, a priest of the Fire Elemental god,

Kossuth. This priest had been working with the building inspector to help destroy those building condemned by the city. It is hoped that the priest will be able to find out the cause of the fire at the Hall of Records.

The reaction of the Knight's Council was even more immediate and pronounced. They immediately printed flyers requesting all knights of the city to notify the Knight's Council of their allegiances and if necessary re-verify their honors.



Knights are requested to provide copies of their official heraldry and names of their recommended (official certificate of knighthood) to the Knight's Council. If they do not have an official heraldic device (official certificate of knighthood) then they must submit the awards and honors they have gained along with the two knights who recommended them for knighthood (Knight's Record Sheet). The records can either be hand delivered to a member of the Knight's Council, or sent via messenger (e-mail) to the Knight's Council. The members accepting this information are:

Brian Burr (BBurr@aol.com): Accepting for the Roosters, Hawks, Griffons, Phoenix, Pillars and ALL squires other than those of the Keepers of the Mystic Flame.

HAWKLC@aol.com: is able to accept the messages for the hawks.

Carl Buehler (Buehler@aol.com): Is taking all Knight and Squire information for all the Keepers of the Mystic Flame.

Lee McClurkin (McCurkinL@aol.com): Is taking all knight and squire information for the Knights of the Right Hand of Tyr.

Greg Sherwood (GregSher@aol.com): Is taking records for all Knights of the Dove.

Todd Smart TSRO (Lucky@aol.com): Is taking all records for knights and squires of the Lady.

The Knight's Council has requested that all information be sent or relayed prior to the first of the New Year. Of course, they have repeatedly vowed to now keep their records in the Hall of the Raven and NOT in the city's Hall of Records.
